

**DECISION  
GB(D)08-2022**

**Adopting amendment n° 1 to the SESAR 3 Joint Undertaking's Bi-Annual  
Work Programme 2022-23**

**THE GOVERNING BOARD OF THE SESAR 3 JOINT UNDERTAKING (SESAR 3 JU),**

**Having regard to:**

- The Council Regulation (EU) 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe and repealing Regulations (EC) No 219/2007, (EU) No 557/2014, (EU) No 558/2014, (EU) No 559/2014, (EU) No 560/2014, (EU) No 561/2014 and (EU) No 642/2014<sup>1</sup> (“Single Basic Act”), and in particular Article 17(2)(f) and (k) and Article 25 thereof,
- Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012, and in particular Articles 6, 18, 71 and 110 thereof,
- The Regulation (EU)2021/695 of the European Parliament and of the Council establishing Horizon Europe,
- The SESAR 3 JU Financial Rules adopted by the Governing Board on 14 December 2021, GB(D)01-2021, and in particular Articles 16, 17 and 33,
- The SESAR 3 JU Governing Board's Decision GB(D)03-2022 of 17 March 2022 adopting the SESAR 3 JU Bi-Annual Work Programme (BAWP) 2022-23,

**Whereas:**

- (1) It is necessary for the SESAR 3 JU to amend the BAWP 2022-2023 to exclude the participation of legal entities established in Russia, Belarus, or in non-government controlled territories of Ukraine in their participation to Horizon Europe (see Chapter I - Introduction and Annex II. Calls for proposals - Full description).

- (2) It is necessary for the SESAR 3 JU to amend the BAWP 2022-2023 to correct a small number of factual errors in the scheduling of activities, indicators and targets.
- (3) It is necessary for the SESAR 3 JU to amend the BAWP 2022-2023 by removing the duplicated objective "Prepare the SESAR 2020 programme closure". The programme closure is proceeding in line with the plan. Given that the operational closure of the SESAR 2020 programme is monitored through dedicated indicators specific to each call, this objective in the BAWP 2022-2023 became redundant. In line with the EU programme cycle, the administrative closure of the SESAR 2020 programme will be monitored with dedicated objectives, activities, indicators and targets to be defined in the BAWP 2024-2025.
- (4) The BAWP 2022-2023 comprises the SESAR JU Budget for year 2022 and for year 2023 pending confirmation from the budgetary authority of the availability of the budget.

HAS DECIDED AS FOLLOWS:

Article 1

The SESAR 3 JU BAWP 2022-2023 is amended in accordance with Amendment n° 1 annexed to this decision.

Article 2

The amended SESAR 3 JU BAWP 2022-2023 shall be made publicly available on the website of the SESAR 3 JU.

Article 3

This decision shall enter into force on the day of its adoption.
